SUBJECT: INVESTMENT REPORT FOR THE MONTH & QUARTER ENDED DECEMBER 31, 2014

The following is summary information for the City of Oceanside Investment Portfolio for the month & quarter ended December 31, 2014.

Market/Portfolio Commentary

Comparative to the previous quarter, bond interest rates during the second quarter FY 2014-2015 ended higher in the 1-month to the 3-year sectors of the yield curve (ranging from 3 to 15 basis points), and lower in the 5-year to 30-year sectors of the curve (ranging from 2 to 34 basis points), continuing the yield curve flattening in the long-end of the curve. Domestic economic data posted during the quarter demonstrated continued growth in the U.S. economy; however concerns over an economic slowdown in Europe and fears over an Ebola outbreak contributed to the higher bond prices seen in the long end of the curve.

Since the Federal Open Market Committee (FOMC) concluded it's quantitative easing program of monthly asset purchases in October, there has been a more concentrated focus by the market in predicting a possible increase by the Committee of the federal funds rate. The Committee maintained the current target range for the federal funds rate at 0 to 0.25% during both FOMC meetings during the quarter, noting both times that although the labor market has improved, inflation continues to run below their expectations. At their December meeting, the Committee said it would take a "patient" approach toward normalizing monetary policy, and suggested an initial increase in the federal funds rate would likely occur around mid-2015.

The book value of the portfolio increased by \$4.2 million comparative to the end of the prior fiscal quarter. Due to uncharacteristically higher expenditures during the second fiscal quarter, the book value increase was lower than expected. Cash flows will be further evaluated to determine the impact on future portfolio investments. The average weighted yield to maturity increased slightly (by 1.6 basis points).

The unrealized losses the portfolio are experiencing is the result of a rising interest rate environment. When interest rates rise, market values in a fixed income portfolio decline. As long as the portfolio securities are held to maturity, the City will not incur any actual losses.

In compliance with the California Code Section 53646, I hereby certify that sufficient investment liquidity and anticipated revenues are available to meet the City's budgeted expenditure requirements for the next six months. I also certify that investments in the City's portfolio meet the requirements of the City of Oceanside's adopted investment policy and the California Government Code section 53601. Market Prices are obtained from Bank of New York and the State Treasurer's Office (LAIF).

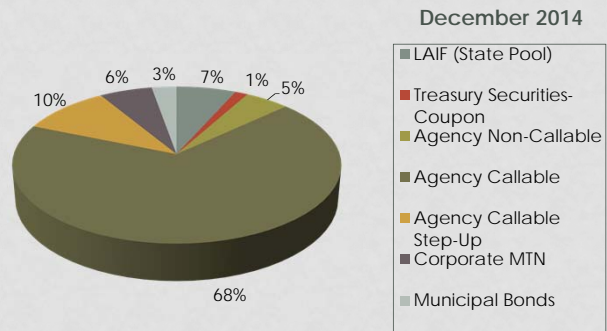

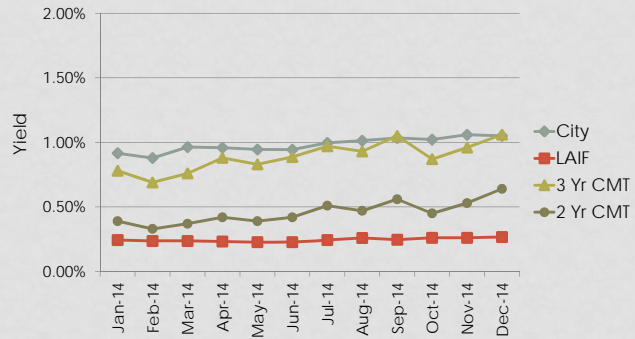
AGING OF MATURING INVESTMENTS

December 2014



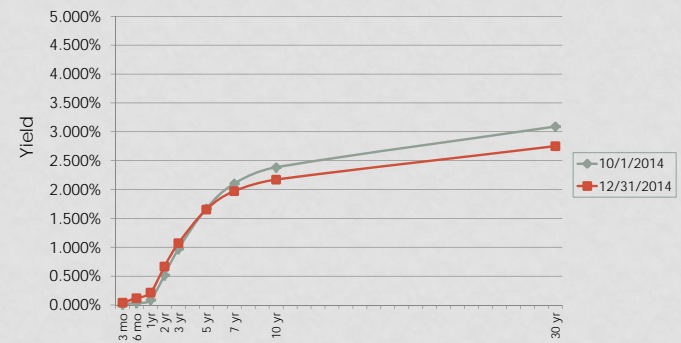
